Student/Athlete Basketball Contract

Dear Parent/Guardian:

Please look over this contract that your son will have to abide by in order to remain a member of the St. Anthony Friar basketball program. This contract is binding, and if any component is not followed, it will lead to indefinite suspension or ultimate dismissal from the program. Please express to your son that this is to be followed and there will be no disputing any transgressions made.

- 1) I will be **on time** for all activities & events at school (**15 min. early**); if there is a problem or a conflict, a parent or guardian must contact in advance.
- 2) I will **represent** myself, my family, my school, and my team **properly** at all times.
- 3) I will take my education seriously, knowing that my education is for a lifetime. I will treat my tutors, teachers, etc. with the proper **respect**.
- 4) I will refrain from the use of tobacco, alcohol, or drugs of any kind and submit to **random urine testing**. The treatment period for any of these infractions will be a **60-day suspension**. Upon completion of the said treatment, **reinstatement to the season will be considered**.
- 5) I will **NOT** take out or use a **cell phone during school hours**. Failure to comply with this rule will result in an **immediate and indefinite suspension** from the program.
- 6) I will always wear both my school and team uniform properly.
- 7) I will **adhere** to my **curfew** hours of **10 PM** for school nights and midnight on weekends. (In season 10pm)
- 8) I will maintain a clean cut appearance with a **short haircut** (absolutely no Mohawks) and **no facial hair**.
- 9) I will not get a **tattoo** during my time in high school.
- 10) I will actively attend my church of choice.
- 11) I will stay away from people and places that will not have a positive effect on me.
- 12) **Theft of personal items from another student at the school** will result in immediate suspension from basketball and we will **suggest to school authorities that criminal action be taken**.
- 13) I understand that **any legal difficulties** will result in an **automatic suspension** until such time as this has been reviewed and resolved.
- 14) I will attend any counseling, tutoring sessions, or physical therapy recommended by the school coaches or staff.
- 15) I will adhere to the rules regarding the appropriate use of jewelry.
- 16) I will **refrain** from the use of **profane language** or **derogatory comments** about others.
- 17) I will **never** involve myself in any **hazing** of another student.

- 18) I will involve myself willingly in all community service activities as a member of the team and in school.
- 19) My involvement in social media reflects on myself, my family, St. Anthony HS, and my team and coaching staff. **The content of this must be appropriate. In addition, a 12:00am curfew on ALL social media will be strictly enforced.**
- 20) **Inappropriate behavior and language when in the company of female students, faculty, staff, & administration will not be tolerated and will result in automatic suspension from the program.**
